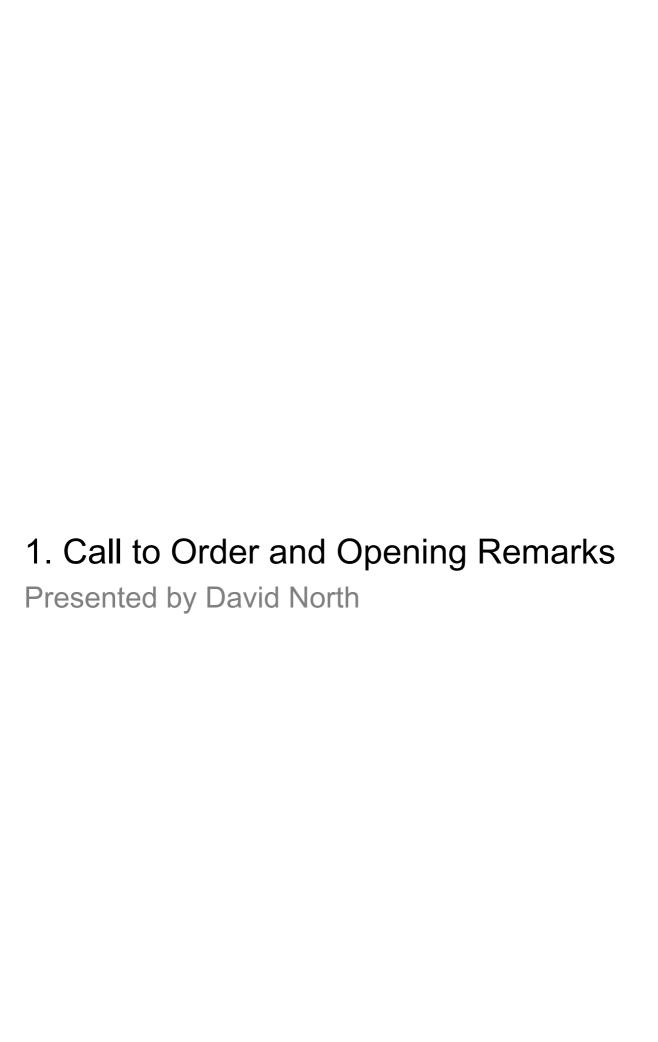

House Settlement – Update

- Roster limits
- ~\$21 Million revenue share can fall into three categories
 - Scholarships
 - Alston Awards
 - Institutional NIL awards
- The above all count towards the "cap" to varying degrees
- External "true" NIL agreements do NOT count towards the cap
 - Robust external NIL opportunities will distinguish athletic programs
 - Institutions can provide services to help student-athletes acquire NIL deals
 - External NIL agreements must be filed with the court to ensure legitimacy
- Final settlement approval expected at the beginning of 2025
- Outstanding questions
 - Title IX
 - Potential legal challenges to the House settlement
 - Fontenot case
- Valuation of the step-up clause year over year

Simmons Bank Liberty Stadium Renovation Update




East Side Renovation


-Conversion of second level suites to press box/game operations space on schedule for completion by August 31

West Side Renovation

- -Demolition began on July 22 and is scheduled to be completed before August 31
- -Phase 2 (west side rebuild) will begin in September and on schedule for completion by Summer 2026
- -Phase 3 (reconfiguration of north tunnel and west side seating deck addition) design will begin in the coming weeks


