1. Approval of the February 3rd Graduate Council minutes

Dr. Kreuz asked if any changes or additions to the minutes were required. No one had any changes or additions. Shelley Keith motioned to approve. Dorian Burnette seconded the motion. All were in favor.

2. Reports from the February 26th College Directors meeting

a) Graduate faculty status policy revisions

The changes to graduate faculty status that Dr. Kreuz described at the last meeting and are summarized in the February minutes will be voted on at the University Graduate Council meeting on Friday, March 6, 2020. Full and external status applications and renewals will be submitted via DocuSign. Department chairs will submit a list of "automatic associates" to the Graduate School every fall.

b) Academic regulation revisions

A UCGS task force has been reviewing the Graduate School's academic regulations. With the exception of the grade and retention appeals, which were overhauled last year, the regulations have not been revised for many years. This is ongoing, but one goal is to run the regulations past university counsel to make sure that they are compliant. For example, language about "capricious actions" is being eliminated. There were no objections to this at the UCGS meeting.

c) UniCAS training

Dr. Jim Kierulff announced that there will be a UniCAS training session in mid-March (after spring break). Representatives from Liaison will also be present. This would be a great opportunity for those of you who are experiencing problems to try and get some answers and to make recommendations for future changes.

d) Student Research Forum

The forum will be held on April 13, and the registration deadline is later this month, on March 27. As always, the Graduate School will need over a hundred judges, so when the call goes out, please encourage your colleagues to serve in this capacity.

e) City of Memphis datasets

Ellen Paddock, a senior analyst with the City of Memphis, gave a presentation on datasets that are available for researchers. There are also several widgets that are updated daily on neighborhoods and public safety, civic assets, and capital projects. There is a Civic Data hackathon later this week March 6-8. This could be a great resource for researchers in the social sciences who may be unaware of it. Dr. Kreuz has contact information for Paddock that he can share with anyone who would like to know more.
