# MINUTES COLLEGE OF ARTS AND SCIENCES COUNCIL FOR RESEARCH AND GRADUATE STUDIES

MEETING: October 31, 2022

R. Kreuz called the meeting to order at 3:02.

## 1) Approval of the minutes from the October 3 2022 Council meeting

R. Kreuz asked for additions or corrections. None were proposed. R. Kreuz called for a motion to approve, which was made by E. Delavega and seconded by A. Daily. All voted in favor.

## 2) Review and vote on the 2022 graduate catalog curriculum changes

R. Kreuz announced that there were nearly sixty catalog changes to be voted on and he hoped that all members had had a chance to review these proposed changes in Curriculog.

R. Kreuz asked for a review by department, in alphabetical order. Each representative would summarize all of their unit's proposed catalog changes for the Council. Some would not require much explanation, such as course description changes, changes in credit hours, prerequisites, and repeatability. He asked the Council members to provide a rationale for program changes, new courses, and course closeouts.

R. Kreuz proposed that the proposals would be voted on in groups, by department. He said that Council members with questions or comments should raise them at the end of each representative's summary to the group. If necessary, the Council would break a department's changes down into separate proposals and vote on them individually.

R. Kreuz announced that as there were visitors present with proposals, they would be allowed to present first and could leave afterward.

E. Delavega entertained a friendly amendment to add "in Social Work" to the title of the 7/8155 course. T. Tardugno pointed out that the 8155 title change wasn't in Curriculog and would need to be added next year.

 $\mbox{M.\,B.}$  Mader asked about confusing language in the 8100 prerequisites. Alternative language to clarify this was discussed.

A. Daily asked if the special courses would be taught in the future or were just a one-off. E. Delavega replied that she hoped these courses would become a permanent part of the curriculum.

A motion to approve was made by A. Daily and seconded by M. B. Mader. All voted in favor.

- 3) Report from the October 7<sup>th</sup> University Graduate Council meeting and the October 26<sup>th</sup> College Directors meeting
  - a) Last day to drop classes policy

R. Kreuz announced that the registrar, Darla Keel, is proposing that we change the last day to drop classes, or to withdraw for the term, from the 50% point to the 75% point in the semester. For Fall '22, this would have meant the drop date moving from October 14 to November 7 (three weeks later). For spring '23, this would mean a change from March 17 to April 10.

The rationale is that in some courses, students just don't have enough information about their likely course grade to make an informed choice at the halfway mark, particularly if the instructor assigns large projects that haven't been graded by that point, or a midterm that is scheduled for after fall break. This would give everyone involved more time.

This is still being discussed, but the Graduate School is in favor, as is the College.

- D. Downey asked if this would change the refund date. R. Kreuz read from Darla's proposal that this issue had been explored and would not create financial issues for students.
- H. Sable asked for clarification regarding dropping versus withdrawing from a class. T. Tardugno replied this it shows up differently on the student's transcript. The timeline for dropping and withdrawing from courses would shift together.
- R. Kreuz urged members to share any thoughts about this with him so that he could relay them to the Graduate School.

## b) Graduate student health insurance update

R. Kreuz announced that this issue is still being actively explored by the Graduate School. They are working with an insurance broker and hope to have options to present to all the graduate coordinators at some point. It's possible that a new plan could be in place for Fall '23, but it will probably happen after that. The Graduate School is planning a meeting with all of the graduate coordinators on this issue. The major issue is where the money could be found for this.

It was asked if this might mean fewer assistantships given to the department, and R. Kreuz allowed that this was a possibility.

- R. Kreuz pointed out that only about 50 students are currently taking advantage of the Memphis (Church Health) plan, and that it is actually better than is commonly believed (e.g., it includes vision and dental coverage). The drawback is that the plan only works locally.
- D. Downey asked about including international students in the Church Health plan, and R. Kreuz replied that this is currently not allowed. International students must provide their own insurance, which can be very expensive.

## c) Time limit for course validation policy

R. Kreuz remined the Council that he had asked you them provide feedback about the Graduate School's proposed changes to the course expiration time limitations (currently eight years for master's student and ten for doctoral students). He didn't hear back from any of you, so he wasn't able to provide the subcommittee with any input from the College.

On Friday, the University Graduate Council will discuss and probably vote on the proposal, which provides departments with a great deal of flexibility for validation—from requiring an examination to completing an independent study, or taking a more advance class, or even just passing one's comprehensive exam or dissertation proposal. The rationale for this is that passing is an implicit demonstration of required mastery in one's field.

R. Kreuz asked for thoughts or discussion about this. A. Daily said that this would be helpful for doctoral students who disappear for a while or master's students who are taking one course at at time.

## d) Dissertation hours prior to the proposal defense

R. Kreuz announced that in some colleges and units, students are taking dissertation hours prior to being ABD. Technically, that's not allowed: students should not be taking these before their proposal defense. The Graduate School requires a policy that applies to everyone, so if your program's students are in the habit of doing this, you should create a prospectus course, or a readings and research course, that they could sign up for while they are working on their dissertation proposals.

W. Duffy says that the nine-hour requirement pushes students to do this. R. Kreuz pointed out that curriculum changes could be made next year to address this.

S. Fleming asked about the minimum number of dissertation hours, which is six. Many of his colleagues in Computer Science violate this, because many students will float off to jobs once they are ABD.

#### 4) New business

## a) Update on hiring Tori's replacement

R. Kreuz reported that the College has hired Stormey Warren as its new Administrative Associate staff member. She's a long-term employee at the UofM and has been in the College of Education's Office of Graduate Student Services for the past 14 years. As a results, she's already very familiar with the Graduate School's forms and workflow. She'll start a week from today, on November 7.

Like Tori, she'll wear three hats—she'll help R. Kreuz with the Graduate School and Graduate Council, and she'll also assist L. Menson-Furr with the Undergraduate Council. Finally, she'll be responsible for other duties, as assigned, by Jessica Abernathy, the Director of Administration. She'll be in Tori's office next week, and he urged the Council members to stop by and introduce themselves if the spirit moves them.

S. Warren has an email address, of course, but R. Kreuz announced that the College is going to create two new email addresses, so that forms and requests are routed appropriately. The idea is to separate roles and individuals, so that a new staff member, like S. Warren, will simply need to be added to appropriate email group.

One of these addresses will be for CAS awards and will be CAS\_Awards. There will be another email address set up for messages involving Graduate School matters, but it's not in place yet. R. Kreuz will announce when has gotten worked out.

- T. Tardugno stated that she trained S. Warren in Curriculog and is very familiar with that system, and also recommended her strongly for the position, adding that she is wonderful to work with.
- D. Downey asked about routing of forms, and R. Kreuz replied that he would provide guidance when the changes are introduced.
- T. Tardugno said she would continue, for a time, to process the graduate faculty status forms, and reminded everyone that renewal applications do not require a full CV or an elaborate explanation: just a succinct summary of research accomplishments over the past six years <u>and</u> a simple statement of why a renewal was being requested (T. Tardugno reminded the members that graduate faculty status isn't required to teach graduate courses; this was changed a few years ago.)

T. Tardugno received a round of applause as Council members thanked her for her service.

# 5) Motion to adjourn

R. Kreuz called for a motion to adjourn, which was made by H. Sable and seconded by D. Downey. Members indicated approval by running for their lives. The meeting was adjourned at 4:01.
