There is a proposal being put forward through the Graduate School to expand Full GFS to allow research faculty to qualify. Council members discussed the pros and cons of the proposal. Consensus was that any faculty with an active research agenda would be qualified to mentor a student through their dissertation. This led to

discussion of the current qualification criteria of 6 publications. Many feel it is restrictive as fields are varied and this approach is not a one size fits all. For example, many faculty in scientific fields hold patents.
