# **Report from the College Director's meeting (September 27)**

**Decision Desk rollout**. Dr. Kreuz reported that several colleges are now online or going live this week, and that the social sciences departments in CAS are up next. Critical updates should be sent to Jim Kierulff.

Acalog. Dr. Kreuz asked if any departments were having issues with their listings:

Dr. Scraba reported that the English department had issues with regard to formatting. Dr. Roche reported that Philosophy has no courses; they are all showing as Physics or Physical Education courses.

Dr. Kreuz asked the representatives to check on what's missing and what needs to be added back in the next two weeks, and to direct all changes to Mary Kyle in the Graduate School. (The old catalogs are still available for comparison in an online archive.)

**Graduation analyst**. Dr. Kreuz reported that Michelle Stout, the graduation analyst for the Graduate School, is retiring, and that candidates for the position are being interviewed.

# Report from the Academic Chairs' Leadership Academy (September 28)

Dr. Kreuz reported that the Emerging Research University Fund initiative has been renamed; it will now be referred to as the RISE initiative (Research Investment to Stimulate the Economy). Dr. Rudd, who spoke at the Leadership Academy meeting, is confident that the initiative will be successful. He expects the state fund to be between \$30 to \$60 million, although the money will have to be matched by the universities. He is already approaching private donors. The president said that he would announce a 5- to 10-year research initiative in December. Dr. Kreuz pointed out that both of these developments would have major positive implications for the College's graduate programs.
