The committee to vote on the correct proposal.
 - 2. Sanjay asked where the Department of Physics' proposals were in this discussion. Ladrica responded that all of the department's proposals were Low Impact Proposals, but they were placed onto course proposal forms, and the not Low Impact form. Hence, they could not be discussed and voted on as part of this block vote. These proposals will be discussed in November.
 - 3. Alistair identified a new course proposal in computer science that should not be listed in the Low Impact category.
