Dear Colleagues,

It has been an honor to serve as Faculty Trustee. I am now completing my first complete term, and I would like to be considered again for a second elected term. Note that the terms for the Governor appointed Trustees is 6 years and that of the Faculty trustee is 2 years. The learning curve is quite steep and the first term has proven invaluable in peparing me to be a most effective Trustee for the next two years. I believe I bring relevant experience, including serving as the current Faculty Trustee, breadth of knowledge, and a commitment to faculty values and shared governance necessary for the position. My curriculum vita is attached.

I have an established record of teaching, research, and service at all levels, as well as administrative experience as a Department Chair (interim) and Director of the IMBA program. Allow me to call attention to past activities and experiences most relevant for this position. I will focus briefly on my experience as a Trustee and my approach for the next two years if re-elected by the Faculty Senate to serve on the Board, and then in more detail on relevant experience in faculty leadership roles.

Given the current state of the pandemic and resulting budget issues, this past year has required very significant budget cuts and reallocations. The upcoming year will also require careful planning and significant input from the faculty. Serving as a Trustee has provided tremendous insight into the structure and operation of University governance from a unique point of view. As I have mentioned at various Senate meetings over the last two years, most of the work takes place by the Administration well in advance of the Board meetings, deliberations take place in the relevant committees; and the whole Board generally concurs with the Committee recommendations. It is also clear that every Trustee is deeply committed to advancing the University and acting in the University's best interests. Most actions regarding academic programs and faculty issues are discussed in detail with the relevant University constituencies and proposals are thoroughly vetted well in advance of a formal proposal. This requires a very active Faculty Senate and serious work by the Senate committees. My role is to provide the faculty's perspective and insights to Board members on all issues. I can, and will, place items on the Board agenda at the Faculty Senate's request if these issues remain unresolved with the Administration, as appropriate and when necessary. I am firmly committed to focusing my attention on budget and finance issues, given the past year and moving forward. Importantly, this includes faculty and staff compensation, the role of on-line instruction postPandemic, and the Carnegie 1 research goals. Of course, there are other issues, including faculty governance and communications, and I will elaborate on these later in my presentations during the selection process.

President Rudd has provided information about the aggregate University budget and the expected revenue determinants moving forward. *In toto,* the University has managed through the financial challenges, and revenues are expected to stabilize and recover as enrollments recover and increase. The build back and distribution of resources within the University are now critical. While changes in enrollments were relatively small, significant revenue falls occurred in auxiliary services. The Faculty Senate has started a review and self-study of Academic programs looking for cost savings and efficiencies. I am committed to maintaining the strength of academic programs and will argue that cost savings from the academic programs review will stay within Academic Affairs to enhance efforts for the movement to R1 status.

Concerning my credentials and background, let me provide further details. I have extensive experience in other leadership roles relevant to this position. While at Wichita State University, the Kansas Board of Regents mandated a 10% budget cut dictated by a university-wide review of every program at each University in the Kansas system. The process was predominately faculty-driven and managed. I chaired the Program Review Committee for the Barton School of Business and was a member of the Program Review Academic Advisory Committee to the Provost in 1991-1992. While the process was quite stressful, sometimes contentious, it was viewed as fair and objective, and the results, advisory to the Provost, were mainly implemented. This experience gave me an excellent overview of academic budgets, goals, and objectives of programs across the University. Since then, I have continued to follow budgeting and financial issues and have an excellent understanding of these issues. At the UOM, I have followed the SRI process with great interest and have been available to Professor Rezae as he leads the Faculty Senate's initiative.

In the Fogelman College of Business and Economics, I served as a member of the Ad Hoc Committee on Roles and Rewards, chaired by David Spiceland, in 1996-1998. This committee wrote the first Roles and Rewards Document for the Fogelman College. This document has been updated several times but still serves as the foundation for defining faculty expectations for annual review and promotion and tenure. I have served multiple terms on the College Promotion and Tenure Committee and an excellent grasp of issues that may arise concerning faculty performance and the fair application of evolving standards.

I have directed or chaired many cross-departmental, cross-disciplinary programs and projects. These include serving as the Pew Scholar in Residence and Director of the Economics and Security program at the Institute for East West Security Studies (now the East West Institute) in New York (1989-1991), Director of a USIA funded collaborative program between Wichita State University and Comenius University in 1992-1993, and Director of the International MBA program here in the Fogelman College from 1994-1997. Also, I have directed several modeling and forecasting teams at the central banks of Armenia, Azerbaijan, and Kazakhstan in multi-year projects. In each case, I reported the ongoing results directly to the Governor and senior management of the Bank. Each of these activities required cross-disciplinary skills and

knowledge, and cultural sensitivity to be successful. Of these activities, probably most important for this position is my role as Director of the International MBA program. My colleagues from the College of Arts and Sciences in foreign languages, political science, and geography who were involved with the IMBA program in 1994-1997 may attest to the accomplishments we made in developing the IMBA program.

Turning to curriculum issues, in addition to the IMBA program, I participated in planning, review, and development of curriculum at nearly every level of the University from the Economics Department, the College (chairing the Ph.D. sub-Council), and the University Graduate Council. In addition, I have served in some way on virtually every external accreditation review since I was an Assistant Professor many years ago.

I have served in many leadership positions in several professional and scholarly organizations, but perhaps most importantly for the Trustee position, I served as Director of the Economic Club of Memphis and was an *ex officio* member of the Board from 1998-2012. As such, I was responsible for all aspects of the management of the Club. I organized and managed the Board's standing committees and occasional *ad hoc* committees as the Club grew from around 120 members to over 200, and the budget nearly tripled. While some may consider it to be "just a club," it is an organization whose membership includes the most prominent Memphis business community members, including many major donors to the University. I have worked with and have the respect of all that have served on that Board over the last decade or so and know several quite well. From this, I understand how the business community feels about the University and have insights into how they may contribute to the University's mission if called upon.

In summary, I have a good working relationship with the current Trustees and am well positioned to convey the Faculty's perspectives and concerns effectively. I believe I have the appropriate experience, knowledge, and skills necessary to serve as the Faculty Trustee. I look forward to sharing additional thoughts and entertaining additional questions at the appropriate time.
