Monday, November 8 – Tuesday, January 18	100% Fee Adjustment/Refund Period – Law
Monday, December 6 – Monday, March 14	<p>Installment Payment Plan (IPP) available to sign-up on TigerXpress. An initial down payment of 10% of the remaining balance of tuition and fees is required and a \$25 non-refundable enrollment fee will automatically be included in IPP plan amount. Beginning January 1, the non-refundable enrollment fee will be \$50.00.</p>
Tuesday, December 7	<p>eBills available online on TigerXpress.</p> <p>Students will be notified by email (U of M email address) when eBills are available and by text messaging if signed up on TigerXpress to receive text messages.</p>
Monday, December 13 – Wednesday, December 29	BAPP (Bookstore Advance Payment Plan) period
Saturday, January 1	\$50.00 Installment Payment Plan (IPP) enrollment fee begins.
Tuesday, January 4	<p>Fee Payment Deadline (4:30 p.m.) for students who register through January 4, 2022.</p> <p>Students who wish to register for courses with remaining seat availability may do so during “Late Registration.” All courses must be paid in full or be enrolled in a designated semester’s Installment Payment Plan (IPP). *Note: To request to register after late registration, you will need to contact the professor of the course for approval. If approved, be prepared to pre-pay in full or have sufficient financial aid/scholarships for ALL fees. You will have five business days from the date that you add the course to satisfy fees to remain in the course. The Spring 2022 Installment Payment Plan option will end at 4:30p on March 14, 2022.</p>
Friday, January 7	Financial Aid Disbursement for Spring-eRefunds (direct deposit) will begin to post to students' bank accounts.

Monday, January 10	<p>Priority deadline to sign up for eRefunds (direct deposit) on TigerXpress for processing excess financial aid/scholarship refunds as available for the initial direct deposit. NOTE: Students who miss this deadline should still sign up in preparation for subsequent disbursement.</p> <p>Late Registration (\$100 Late Registration Fee)</p> <p>All Late Registration will be assessed a \$100 Late Fee. Please note: If you decide to withdraw completely from the University, your courses should be dropped promptly before the post fee deadlines to avoid owing fees.</p>
